Function (22/23 & 23/24)

1. FINANCIAL MANAGEMENT:

- · Planning the safe transition of specialised commissioning spend to ICB ledgers
- · Testing of accounting, cashflow and other national standard operating procedures (SOPs).

2. DATA ASSURANCE

- Testing attribution of current specialised financial flows across ICB populations and retained National/ Regional commissioning arrangements, including clear articulation by Trust, by service and by population.
- · In depth work across NHSE, ICBs and providers to test comparability of service line reporting and costing ('like for like').

3. FINANCIAL & CONTRACTUAL DEVELOPMENT

- · Recommendation of processes for in-year review of disaggregation to ensure cost neutrality going forward.
- Overseeing the development of specialist Indicative Activity Plans (IAPs) for South London providers, shadow monitoring against IAPs and wider specialised commissioning reporting.
- Testing the operation of Elective Recovery Fund (ERF) for specialist services, linkages to Trust and System Patient Tracking Lists (PTLs) and the impact of EPIC implementation.
- Ongoing financial oversight of pilot funding approaches and preparing ground for transformation opportunities (including whole pathway costing).
- Development of medium term financial planning for specialised services including assessment of the impact of national allocation and funding flow changes.

4. WAYS OF WORKING AND SHARING LEARNING

- Development of matrix team approaches across organisations (providers, ICBs, Regional & National Teams) and across muti-disciplinary teams (contracting, BI, finance).
- Recommendation of national finance and contractual arrangements for 2024/25.
- Development of lessons learned documentation for national teams, Regions and ICBs.
